NOTICE OF REGATTA

## 67<sup>th</sup> ANNUAL LABOR DAY INVITATIONAL REGATTA 2019

MARSHALL BEACH

TOMALES BAY

Friday, August 30, through Monday, September 2

Pre-Registration: \$50 per boat for non-members; \$45 per boat for SRSC members  
(On-the-beach Registration \$55/\$50 per boat) (Camping on Beach is included)  
Camping fee for those **not** registering a boat in the Regatta: \$20 per person

To qualify for the regatta, a yacht must complete a written entry form. **Pre-registration entries should be received by the deadline of August 8 for those ordering shirts; and August 24 -if not. Regatta shirts are only available through pre-registration.** Beach registration will be available from 10:30 to 12:00 on Saturday (8/31). Pre-registered yachts must also check in during this time period. At the discretion of the Race Committee, late entries may be accepted until the first race Sunday.

The RACING RULES OF SAILING 2017-2020, as published by US SAILING Association will be used for this regatta. Wearing PFDs is mandatory while racing. A 15 ft topline is suggested. Sailors on centerboard boats should wear wetsuits as the water is dangerously cold. Don't forget this is a Coast Guard jurisdiction, and an equipment check is a possibility. The Coast Guard Auxiliary may be present Saturday and Sunday. **All attendees are advised that the Santa Rosa Sailing Club will not provide rescue boat service.**

Camping is on the beach at Marshall Beach, above the high-water mark, for Friday, Saturday, and Sunday nights. Those who wish to have any personal campfires at any time, or to camp prior to Friday night, or those camping Monday night, will have to make their own camping and fire permit arrangements accordingly. (Contact Pt. Reyes National Seashore Headquarters at Bear Valley.) The Santa Rosa Sailing Club cannot make reservations beyond the group permits already obtained (65 campers including children-for Friday, Saturday, and Sunday nights and permits for three Club campfires). Note that there are toilets at the camp site, but there is NO POTABLE WATER available. Please bring sufficient water with you. There are National Park Service rules about bringing dogs with you. For those sailing boats too small to carry camping gear (e.g., Laser), please contact Bill Daniel (below) by 8/23, so that the Club can coordinate transport aboard the other participating boats.

Those who wish to bring items for the Saturday 6:00 P.M. hors d'oeuvres party on the beach, we welcome your participation.

At Miller Park launch ramp, overnight parking is on the upper level only. Marshall Beach is approximately 2.1 nm south of this ramp. **For those used to launching at Marconi Cove, be aware that the property may be posted as "no trespassing" or blocked.** Marshall Beach is approximately 2.3 nm northwest of this ramp. The SRSC does not endorse violating any restrictions on the use at posted property. Please consult appropriate nautical charts. Links to maps and charts can be found on the SRSC web site.
